## Reported that:

The draft newsletter refers to the speed radar signs being erected. Erection must be swift,

so the article is factually correct.

St Pirans day is being celebrated at Marazion School on Wednesday 5th March 2025, 2.25pm, Marazion school playground. All are welcome to come and support.

He is disappointed about the unhelpful social media comments about the Maypole Gardens refurbishment especially as there is still work to do. Comments are also being made by those who do not live in the town. One comment which was truly deeply offensive which was removed. People are entitled to their opinions, but the adverse negativity is unnecessary.

He had met a person who is engaged by Cormac to work on community volunteer projects looking after green spaces. Initial thought was the cycle track, planting of trees as well as help around the town. Consensus was that it would be a good idea.

For information purposes, a local landowner has had to open access to their land which runs adjacent to the closed section of Footpath 14 in Marazion. Cornwall Council has no right to prevent access to their property or land.
